Terms and Conditions

Definition and Validity of Fee

To be eligible for the stated Swiss

Resident fees:

- The student must hold a valid Swiss Passport

or

- The student must hold a valid B/C permit (B permit for study purpose excluded)

or-

His/her parent holds a Swiss Passport or is currently residing in Switzerland holding a B/C permit.

Swiss Resident fees are applicable for the campus located in Switzerland and for new students only. Swiss Resident fees will be applied based on the student's and parent's status when the application is received. Current and returning students are not eligible unless Swiss Resident fees were granted when they started.

Please note:

Students and parents with a diplomatic status (carte de légitimation) are not entitled to the Swiss Residents tuition and other fees as outlined. All other students and sponsors are subject to fees for international students.

Application Fee

A non-refundable fee of CHF 275 is required with each application for Les Roches Global Hospitality Education. Please see section on "Method of Payment".

Damage Deposit

A refundable damage deposit of CHF 1,000 is charged with a student's first invoice and will be reimbursed three months after the final check-out at the end of the studies.

The deposit covers any costs due to damage to Les Roches property as well as any remaining

balance, if sufficient, at the time of the final check-out.

Compulsory academic expenses

Tuition fees cover

- School supplies

- Access to academic facilities on campus (e.g. library access, innovation lab and digital learning support) and academic tutoring and support

- Access to recreational facilities on campus (e.g. student gym, student events space, etc.) and access to sports activities and training

- Health and wellbeing support (basic medical and counselling support by campus nurses, campus counsellor)

- Career and internship guidance and professional development opportunities (career fair, industry workshops, personalised counselling, etc.)

- Health and wellbeing support (basic medical and counselling support by campus nurses, campus counsellor)

- On-campus security service 24/7 through Les Roches Campus Security

- Free membership and access to off-campus services through TSM (e.g. while on internship) such as medical and travel security assistance (incl. 6 days pre-arrival and post-departure to and from Crans-Montana)

- Access to specific campus organized events (e.g. leadership series, industry events) and extra-curricular activities and conferences (may incur participation fees depending on type of activity)

- Cantonal and communal taxes

- Communal benefits card "My Explorer Card" (granting free access to specific outdoor activities, bus services, lifts, etc. in Crans-Montana and neighbouring communities during specific periods) for students living on campus. For more information, please consult crans-montana.ch/myexplorercard.
 - Swiss regional administration charges for Visa and resident permit (excluding where there are legal and court charges if the Visa or work permit has been refused and an appeal has been made by the student)
 - Swiss VAT
 - Contribution to examination costs (except resit or retake examinations)
 - Access to Microsoft Office automation licenses
 - Reception and postal distribution service on campus
 - Contribution to Alumni lifetime services.
- Please note any unused services, clothes, supplies, benefits, etc., included in the main fees are not refundable

Learning Resources

Learning Resources are tailored to suit the needs according to each semester level and program and usually comprise a variation of different support material such as textbooks, digital resources, online accesses to software and databases, copyright and licenses, kitchen tools (for practical programs) as well as practical arts apparel (kitchen, housekeeping and service uniforms) for specified programs.

All Bachelor Experiential Year Practical semester students will receive a pre-loaded iPad containing e-books, videos and digital content to support the learning experience. Any students wishing to order printed text books may order them through the school at an additional cost. For direct entry Bachelor students the purchase of the iPad and the digital learning resources (CHF 1,000) is compulsory.

A detailed overview of the different learning resources can be provided upon request once on campus.

Les Roches for life career support

This service provides a personalized support during the professional career and as well once the student is graduated.

Administration and service fees

The administrative costs related to the student's study visa and residence permit (excluding legal and court charges if the visa or permit is refused and an appeal is made by the student), as well as administrative services such as local/national fees obligations, administration charges for internship(s). Any monies relating to unused services, clothes, school supplies, benefits, etc. included in the academic compulsory fees are non-refundable.

Laptop (device & service support - optional)

Les Roches students will be given individual access to our learning platform, which hosts student information, including support and teaching documents and other learning resources.

Business field trips / Immersive experience

(compulsory for the concerned programs)

Business field trips or Immersive experience are a compulsory part of the program and bear academic credits. Depending on the program, there could be a business field trip, immersive field visit or Exclusive brands week. Expenses are estimated and subject to change with currency variations and other factors. The business field trip fees include transportation (to/from airports), flights, lodging, half board and other school-planned activities.

Fee associated with lodging and board

On-campus accommodation

On-campus accommodation is compulsory for Bachelor students during Practical semester, and BSc year Semesters 1 & 2, as well as for all Bachelor direct entry and Bachelor exchange students transferring to Les Roches Crans-Montana for the first time. The standard rate covers accommodation in a shared Double Room for Bachelor BSc Semesters. The single room is available upon request and based on availability for BSc students (S1, S2, S4, S5). After the downpayment is made, all students choosing the school accommodation will receive instructions by email on making a room reservation in our online lodging platform. Students' rooms are only confirmed upon the receipt of the full payment of fees as per payment deadline.

Les Roches on-campus accommodation includes all costs relating to heating, electricity, maintenance, bed linen, housekeeping service (once every two weeks), free wifi and residential kitchen facilities.

Full (residential) or flexible board

Full board in Crans-Montana includes three meals a day, five days a week, as well as brunch and dinner on Saturdays and Sundays. For students, who received written approval from the Executive Management Team to live off campus, the compulsory flexible board option can be upgraded to full board upon additional payment. Students on flexible board have a "credit" of 170 meals to use during the semester at their own convenience (breakfast, lunch, dinner, weekend brunch). Once this "credit" consumed, additional meals will be charged separately.

Insurance

Health insurance coverage is compulsory by law in Switzerland. Therefore all students are automatically covered with the insurance

provided by the school. This covers them for health and accident, while on campus and on internship, at the most competitive rate, which may vary from one semester to another.

However, if a student has a private, valid insurance cover equivalent to the Swiss health insurance cover scheme, they may request to get exempted by the Swiss authorities before their arrival on campus. Failure to complete the request, the insurance provided by the Institution will apply. Information about the exemption and comparison between private and school insurance is available from the Admissions department or from the Les Roches website lesroches.edu/apply/accepted-student-information/pre-arrival-information/. Students keeping their private health and accident cover are responsible for verifying that their documents are valid while in Switzerland or abroad. Les Roches will not cover any related expenses. Personal and private insurance, to cover issues such as damage or theft of personal property, is not compulsory but is strongly recommended and is the student's responsibility.

Les Roches cannot be held responsible for the theft of personal belongings, student damage or third party insurance. The health insurance fee for the internship semester(s) will be charged on the invoice for the previous on-campus semester.

Personal expenses

It is estimated that students require on average sum of CHF 500 per month to finance their out-of-pocket expenses such as snacks and drinks, entertainment, personal supplies, laundry, and any other personal expenses.

Internships (if applicable)

Although internships are generally paid by the employer, the remuneration received cannot be expected to finance studies at Les Roches.

Visa application procedure for accepted candidates

As some students will require a student Visa to enter Switzerland, they are kindly requested to verify Visa requirements for their nationality and apply at the right time.

Please note that it may take at least 2-3 months to obtain a student Visa. Once the acceptance package is received, new students should apply for their Visa as soon as possible and speak with an Educational Counselor for any questions about the procedure.

Downpayment (reservation)

New students: upon receipt of the conditional offer letter, a downpayment of CHF 5,000 is required to secure your place on the program. The downpayment can be made by bank transfer or online platform at lesroches.flywire.com.

This non-refundable deposit guarantees the reserved place in the program and is automatically deducted from the first semester's invoice. In case an accepted candidate postpones his/her studies, the balance will be carried forward to the next two subsequent intakes.

Late cancellation fee & refund policy

Except as described hereinafter, all fees outlined and paid for are non-refundable. If a new student cancels before the official arrival date on campus, only the downpayment (reservation) will be retained (see above). If a returning student cancels his/her studies after the deadline mentioned below and without a written notification, a late cancellation fee of CHF 3,000 will be charged to the student's account:

New students :	15th of May (for the Fall intake)
	15th of November (for the Spring intake)
Returning students :	15th of June (for the Fall intake)
	1st of December (for the Spring intake)

If a student is suspended, expelled, or withdraws on his/her own wish once the semester has started, no fees will be reimbursed. In case of mitigating circumstances (e.g. medical, financial hardship, or similar), validated by a member of the school's management as part of the early check-out procedure, exceptions may apply. At the end of the studies (or if the student definitively withdraws), the sponsor can claim for the refund of the positive balance for a maximum of two years after the last official check-out day of their last on campus semester.

Payments

Unless a payment plan contract has been approved, payments must be made in full in Swiss francs no later than :

New students : 15th of May
(for the Fall intake)
15th of November
(for the Spring intake)

Returning students : 15th of June
(for the Fall intake)
1st of December
(for the Spring intake)

Payments can be made by bank transfer, check, credit card or online at lesroches.flywire.com.

Students will not be permitted to begin their studies until payment for the semester has been received. Swiss Residence permits, academic transcripts and degrees are only delivered / awarded upon full settlement of all outstanding fees.

Method of payment

Les Roches has partnered with Flywire to provide you with an easy and secure method of sending international payments.

- Pay from any country and any bank, even by credit card

Financial aid and Scholarship

Les Roches provides a limited number of scholarships for new students. The scholarships are competitive and linked to Les Roches' admissions strategy which aims to assist motivated young people to study at our institution. Each scholarship has specific criteria. Eligibility for a scholarship is examined on a case-by-case basis for those candidates who have submitted a complete application. Returning students faced with extreme financial difficulty may apply for Financial Aid with the Registrar at registry@lesroches.edu (subject to conditions). Applications must be made at least four months prior to the start of the intended semester of study.

Review of fees

Les Roches reserves the right to review and modify the tuition fees of each semester at any time and without notice.

Sponsorship

Sponsorship is a financial commitment by a sponsor (parent, legal guardian or any other person) where the sponsor undertakes to pay any fees and other charges on behalf of the student. Notwithstanding any sponsorship commitment as part of the application process, the students remains liable for any outstanding debt.

Any reference in these Terms and Conditions to liability of students shall also infer liability on the sponsor of the student as the case may be and such liability is joint and several.

Exchanges

As part of their academic program at Les Roches, students may be offered the opportunity to study in another Les Roches or Glion campus (Glion is a sister school also accredited by NECHE and SAC with campuses in Switzerland and the United Kingdom). Such opportunities are subject to approval by Les Roches as per selection criteria determined by Les Roches at its sole discretion. The opportunity to study in a Glion campus is however limited to one semester across the program (and possible during certain semesters only). As a limited number of students may benefit from these opportunities each semester, Les Roches does not guarantee that any student may benefit from these opportunities. Students interested in such opportunities must comply with the then-current procedures and deadlines (files are reviewed by Les Roches on a first come first served basis).

In case of acceptance, the student will pay the tuition and other fees applicable for the concerned semester(s) directly to the host campus according to the rates applicable at the host campus for the concerned semester and Les Roches does not guarantee that any scholarship granted by the Les Roches home campus will be maintained by the host campus as the case may be. Students will also be solely responsible for any other expenses incurred, such as but not limited to travel expenses, visa fees and any other private arrangement for the semester(s) in the concerned host campus. Students are usually given a week after official acceptance to cancel their exchange without incurring any fee. After this deadline, a cancellation fee applies. During their semester(s) abroad, student shall at all times comply with all rules, regulations and policies of the host campus, as they may be revised from time to time, including without limitation those related to academic, disciplinary, residency or financial matters.

Transfers

Les Roches also offers the opportunity to permanently transfer to another Les Roches or Glion campus. Such opportunities are subject to standard admission rules of the host institution. Degree will always be delivered by the institution where the student finishes the final year of academic study. All Les Roches & Glion degrees are accredited by NECHE and SAC.

Semester Abroad

Les Roches may offer Semester Abroad programs for students from other institutions worldwide. The purpose is to enable such students to enrol in proposed subjects at Les Roches for credits which may then be applied towards their degree at their home institution. Such students follow the Study Abroad program as non-degree seeking students and are enrolled at Les Roches as full time, “non-award” students for the duration of their Study Abroad program. Successful completion of the Study Abroad program, will usually result in the award of 15 credits by Les Roches unless otherwise indicated by Les Roches. It is the sole responsibility of the students to obtain official academic approval from their home institutions for subjects taken at Les Roches to ensure credit recognition. Les Roches have entered into agreements with partner institutions to offer such partner institution’s students specific Semester Abroad opportunities at Les Roches. In case of discrepancies between the terms of such agreements and the terms herein, the terms of such agreements shall prevail.

Accreditations

Les Roches Global Hospitality Education is accredited by the Swiss Accreditation Council (SAC) as a University of Applied Sciences Institute and the New England Commission of Higher Education (NECHE).

Accreditation of an institution of higher education indicates that it meets or exceeds criteria for the assessment of institutional quality periodically applied through a peer review process. An accredited college or university is one which has available the necessary resources to achieve its stated purposes through appropriate educational programs, is substantially doing so, and gives reasonable evidence that it will continue to do so in the foreseeable future. Institutional integrity is also addressed through accreditation.

Accreditation is not partial but applies to the institution as a whole. As such, it is not a guarantee of every course or program offered, or the competence of individual graduates. Rather, it provides reasonable assurance about the quality of opportunities available to students who attend the institution. Institutional accreditation allows graduates to transfer to other institutions with an internationally recognized degree.
